# 1. Finance: Report summarized below and approved subject to audit.

- -Account status \$138,783.57 on 2Dec2021 after distribution of Breakfast funds to AUX, SAL and KOC.
- -Quickbooks: Oct2021 net operating income \$2,966.24
- -SAL current total funds available \$17,139 plus \$5,055 Children's Christmas Fund as of 12Oct2021
- -Aux current total funds available approx \$21,600
- -Donation tracking: recent \$350 assigned to named accounts, \$880.41 for specific purposes to be tracked until expensed.

#### 2. Adjutant - Membership:

- -Membership update: 620 listed members for this year versus 572 last year.
- -Paid Members 497 or 87.9% of 565 with 66 New members since July, 38 PUFL, 392Trad/Renewals, 1 Trans. Paperwork for 17 new members (included in the 66 above) circulated and approved for membership.

#### 3. Service Officers.

- -Veterans Affairs Director Gary Easterling met with 28 Vet's 12Nov to answer their questions about claims. Larry will start the planning process for a followup visit targeted for late Spring 2022.
- -Larry reported recent/ongoing discussions with Veterans having PTSD and questions about disability.

## 4. Club Facilities and Operations Committee

- -Calendar not reviewed for Dec2021.
- -Thorough kitchen cleaning recommended and approved for a cost not to exceed \$500.
- -Bar open to public nights scheduled for 18Dec Christmas party and 31Dec New Years Eve party

#### 5. AL Events

- -0800-1000 11Nov breakfast at Post 49, color guard salute at Post 49 was attended by 40 people, Followed by salute and blanket presentation at local nursing home and Lincoln School (rainy day drive-by).
- -1200 7Dec short ceremony with three-volley salute, taps planned. Meet1100 at post with gold braid.

# 6. Family Meetings - SAL Events

-Larry Carlson Thanksgiving Memorial Dinner 21Nov2021 supported 200 takeout meals and 50-60 inside diners. Leftover turkey vacuum packed and frozen for future AL Post 49 event. Many legion family members supported the dessert menu including Val McPeak who not only supplied many but also served desserts during the dinner period..

#### **Unfinished business**

- -"War on Terror" meeting room display. Team still planning on wall mounted content and will consider using the 2 plaques awarded earlier by Patriots Garage.
- -Kitchen freezer strategy TBD.

#### **New Business**

- -19Nov happy hour and \$8 open-to-public turkey dinner supported by Joe Wiegand's performance as Teddy Roosevelt's impersonator raised \$360 for SAL. Plan to dedicate at least one Boy's State scholarship in Joe's name.
- -West facing sliding door leak. Replacement alternatives several thousand dollars and Mike will work with Steve Hamiliton to develop repair (vs replacement) alternative, targeted for late spring 2022..
- -Jim Montgomery requested earlier that we consider taking some action near term to attenuate or dampen noise level in the clubroom. It was suggested that fixing would require some experimentation and initially hanging a large flag in the area (that could later be placed on an outside flag pole) would give us some experience.
- -Discussion, recommendations and approval for AL donations, targeted for 31Dec completion, summarized on attached pdf. \$5,200 were approved in this meeting and \$1,296 previously for a total of \$6,496 this year.
- -It was also suggested that we develop a standard donation letter that would request a donation receipt.
- -New comments added to the pdf include:
